\* Small Pets must be inside of a pet carrier AND the pet carrier must be able to fit on or in between the seats on the bus.

You will not be reimbursed for the transportation of your pet(s).

All Priority 2-4 riders must have a back-up plan for transportation to the airport if space is not available.
